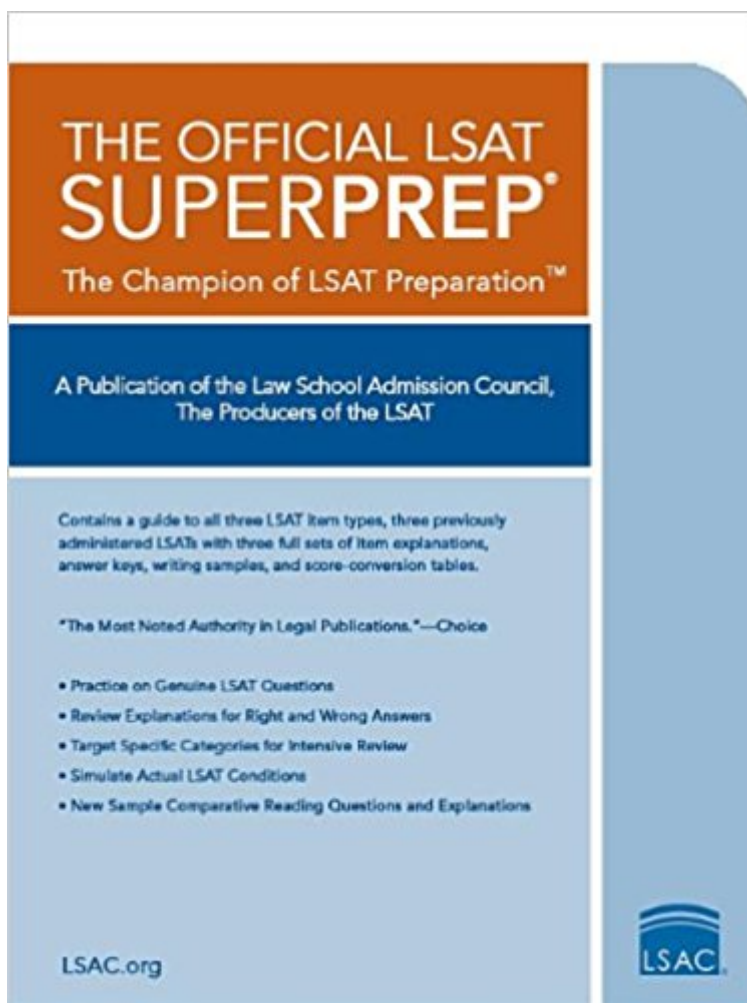

This is a good book if you're either beginning to practice for the exam or at the end of your study schedule. The tips about each section are very useful, but i did find that they were lacking. These sections are not thorough. You might need to consider buying some other book in order to fill in those "blank spaces" left by SuperPrep I. On another note, the logic games (analytical reasoning) in PrepTest B and C are just plain brutal. They are some of the most difficult I've tried, so if you're looking for LG challenge, here you've got some worth your money, in my opinion. However, be

careful: these games are not recent. They're from the mid -to-late 90s.

It was mailed right on time. Amazing price and condition. I highly recommend this practice book. It explains why each answer is correct/incorrect.

Disappointed that the techniques by question type were the same as SuperPrep I. However, they add comparative reading to the practice tests, so I would recommend this over SuperPrep I.

These are great tests and the insight for taking it and prepping at the beginning is so valuable. Glad I found this!

The book outlines how to answer each question type and provides the foundation for accurate analysis when evaluating answer choices. This book is produced by LSAC the "makers of the LSAT". However, diagram techniques are not provided to solve for analytical reasoning problems (also know as logic games). The explanations are very thorough and unambiguous. Do use this book as a foundation for your study. The techniques and suggestions provided aid tremendously in answering the Reading Comprehension passages. What this book does not tell is how much time you should spend in reading the passages and solving the answers. I give this book a 4 star rating instead of a 5 because it doesn't include diagram techniques.

This book is a must. After just one read my untimed score was raised 10 points (on the first untimed test I took after reading the book, I answered 16 more questions correctly than the correct number of answers I'd been averaging on 4 untimed tests I took before reading the book). I don't think it hits on every single question type though, but overall its an invaluable source of insight into how the test-makers think. The language is dense, but it's great practice for the LSAT and future lawyering.

In depth as needed.

This book is pretty good if you're looking for only one book to prepare for the LSAT. It has general strategies for each section that are useful, but students that spend more than a few days studying will find it inadequate. This is a great introduction to the other test preparation books that are category specific (reading comprehension, logic games, logical reasoning). With just three actual tests, this is just a beginner book--great if that's all you want, but maybe unnecessary for those

looking to prepare over a few weeks/months.
